

## Volunteer Tutor Code of Conduct

The primary goal of IFL's TutorMate programme is to enrich and improve the lives of children, and our online volunteers have a central and rewarding part to play in helping young children gain the skills and confidence that will help them to succeed in school and beyond. **Thank you very much for volunteering your time to help with this important task!**

Volunteer tutors work directly with pupils, in support of the classroom teachers, to help boost children's reading attainment, their enjoyment of reading and to provide encouragement and praise for their pupils. Appreciation and respect for each pupil as a unique individual is critical to working effectively as a tutor. Self-worth and self-confidence are important building blocks in the learning process.

Teachers are in charge of the instruction and the discipline of each pupil. The tutor's job is to guide and encourage the pupil to enjoy reading. At times children of this age may appear distracted or disengaged, especially if they find a task hard. Please persevere and give them as much encouragement as you can! The personal interest and attention tutors show pupils may well be the catalyst for the pupils to recognise their own innate abilities to improve and achieve.

The commitment that volunteers make to pupils is a significant one. As they establish relationships with their pupils, tutors are looked upon as role models. Therefore, it is imperative that volunteers conduct themselves in an appropriate and responsible manner by following these guidelines:

- Remember that you are in a position of responsibility and should use language carefully
- You must speak in a manner appropriate for the age group e.g. no swearing, no suggestive or derogatory comments
- You must not interact with children under the influence of alcohol or drugs
- You must not share your own personal information, email addresses, mobile or telephone numbers, home addresses, or Facebook or other social media access with the children you are reading with, nor ask for the same details from the child.
- You must not ask for personal and/or contact information from pupils.
- You must not offer to send children gifts or money or make promises to them that cannot be fulfilled
- You must consider any and all information about the pupils as private and hold it in the strictest confidence.
- While working with your pupil, you should always respect and appreciate the extensive cultural diversity which they are likely to encounter. You should never espouse any manner of religious, commercial, or political views.
- As part of your registration, you are asked to read and agree to the Innovations for Learning Safeguarding Policy and Procedure. As indicated in this documents, if a pupil shares information which leads you to be concerned about possible abuse, you should report this immediately to IFL by completing the Rapid Reporting Form (appendix 1) and emailing it to [safeguarding@innovationsforlearning.org](mailto:safeguarding@innovationsforlearning.org) This form can also be found in the Knowledge Base of the TutorMate platform.
